Frank told me back in April that he wanted to leave the country for a little while as soon as possible. We root for him to be the guy who one day soon enough gets people like Paul Whelan back home from Russia or represent his favorite TV show's South Park's court cases when Scientologists sue them. I remember everything Frank tells me and he does not make legal statements to his clients without talking to multiple experts around him first. Hopefully the reason he's not answering his phone calls from me isn't because he left the country already. I have no way of telling.
