I am going to formally announce my intentions to sue Orleans County Jail the minute I am able to. I will find out through Frank Passafiume if this letter made it to John Sinatra's courtroom.

Why does [enemy inmate] of [city] know it was me who told this very courtroom that he was getting Suboxone into this jail? They put him in "keyblock" (or whatever they call that form of solitary confinement) for 40 days which clearly was not good enough. He sat across the table from me Monday July 1<sup>st</sup> at jail church and told everyone I sent a letter to this very federal courtroom about him. They put him back in the normal section where Richard Greer and Jon DeJesus are while I remain in the room I am in for no reason at all. He gets released from this place on July 24<sup>th</sup> he says. He walks by my room and spits. Check the cameras.

What the fuck did I do to deserve this? Niggers like this need armed supervision, not me. Orleans County Jail is going to be sued and that is a promise. No other jail or prison has this happen. I was calling Olean Police late 2021 because I am a homeowner and my house was broken into. Olean Police as well as Andrew and Krystie at the failed Buffalo FBI lied to me to do this to me. I am glad Andrew and Krystie the failed FBI agents were held to account in court June 2023 for their lies. They should be fired.

I will say "nigger" in writing all I want. Hunter Biden said it over texts. Who the hell told [enemy inmate] I told this court about him? Confidentiality be damned. What is he going to get his Black Panther group to do to people in my life? Check the cameras, he walks right by my room and spits. They let him do this while they tell him what I tell this court. They helped him get Suboxone in.

Orleans County should be banned from holding fed cases the same way Erie

County Jail was? Why has Cat Share been here since the end of 2023 saying his probation officer lied to him? I lied to the court run by Sanford Church I should say. Why did Dennis get sentenced to 20 months for a DUI he has papers saying someone else signed and said he did it? Why am I being spit on by a free ranging [enemy inmate] right on camera? Might I add he has his people look up all the people associated with my very case.

I think I should sue Katie and get them to put that car loan debt into her name she got repaid in 2023. How much does she seriously speak with this jail's staff and other inmates about me? Is this new prosecutor cooperating with Katie since he made illegal suggestions in court April 2024?

Am I going to die at Orleans County Jail the same way fed cases died at Erie County Jail? I came with quite a life of plenty of good references who knew me in a better form. If I didn't then why wouldn't Katie have even been there for me in the beginning before Andrew and Krystie and other law enforcement friends of theirs like [probation officer] who I did not know yet got her to turn on me? Katie will be sued because of that car debt. That is all she ever did to guys she dated, like [ex-boyfriend] especially. Why is she on a recorded phone line at this jail knowing I am in this room?

Every single in North Carolina needs to be sued so they can answer questions as who forged my signature in a Burgaw NC court I never stepped foot in. I will definitely work on that one. Finally every can prevent Brett and Lauren from raising their two other homeschooled sons to blow up a police station.

Need I continue on and on and on over letter to this very court? Frank does not answer the phone, sending letters to the court is my only way of guaranteeing reception.

Counterman v. Colorado 600 U.S. 66 was vacated and remanded on June 27<sup>th</sup>, 2023 and other cases followed similarly. I remain in stalemate getting spit on by a two time attempted murder convict after getting remanded before Christmas for absolutely no reason. Again, why was [probation officer] cooperating with Katie's lies to the [city] Police Sept, 2023 before this happened? Nobody has regard for any of his supervisor's thoughts on things so let's put that in writing.

Orleans County Jail will be sued and [enemy inmate] is the last straw. I have to live in constant fear of losing everything I ever worked for in life without armed supervision hovering over me telling me to do so. Armed supervision is my name for probation.

Is Katie getting audio clips of my phone calls at this jail and working with her obvious counterparts to produce falsified evidence to use against me in court?

This court does not realize I spend more hours per day than not imagining the happier pursuits I could be embarking on in this very courtroom. I would love to pay my mother Janet McCaul back for paying every dollar these last 2.5 years by getting a hotel built in Salamanca for her. The court is aware of our connection to Michael Crick of the Salamanca Planning Board. I imagine facilitating U.S. Dept. of Labor agreements with native american family contractors we know like the Hoags or the Watts of Salamanca, right in this courtroom. I spend more hours per day than you think visualizing future better times in this very courtroom than you realize.

But then issues like [enemy inmate] of [city] happens. He is over there with Jon DeJesus, a former corrections officer turned rape case mind you, and it is an honest statement when I say they knew Katie [enemy inmate]'s name to no influence of my own. Katie is on a recorded phone line knowing I am in the room I'm in, and then [enemy inmate] gets out of his punishment room while I've been here in this room for

no reason and he spits in here with the cameras watching. I am not going to jail church nor "recreation" because of him.

I was at Barack Obama's first inauguration with my uncle and grandfather Paul Wenke in 2009. I helped Larry Sharpe run for Governor in 2018. If I hated black people by default, why would I help them? [enemy inmate]  
goes around blaming white people for everything. He gets out July 24<sup>th</sup>. Why is now on his kill list? Did Katie set him up with Damani Crockett? Katie has evidence of her connections to Damani Crockett.

The legitimate sentencing guidelines maximum of 9 months has officially expired. I am more forgiving of busy lawyers than I might seem but then again, [enemy inmate] and the like. I would rather shake a prosecutor's hand like an adult than call him ignorant to the B.O.P.'s procedures in writing. I would rather introduce an Italian American judge to my own mother's Italian relatives like our cousin, P. K. (who is friendly to Carl Paladino) who can talk about our grandfather Ergildo Martinelli's dealings with the Pope than I would constantly air grievances in writing to a judge's courtroom week after week.

"Chello" (his nickname) is back across the room from me after a brief transfer to Niagara County Jail. He told me he saw Alexander Anzalones old client Kashika Speed again. Chello said Kashika's entourage is constantly out there trying to force Alex into helping every one of their demands. Alex told me Kashika's family has been finding ways to force Alex into cooperating for a little too long now. I hope Alex is fine out there. The Anzalones would prefer the company of Chuck Schumer's friend John Crawford of the Olean Common Council whose phone number is in the possession of Frank Passafiume thanks to my father.

I hope for better days with this court, -Luke Wenke
